A public meeting of the Citizens Coinage Advisory Committee (CCAC) was held on Thursday, September 28, 2018, to review and discuss the candidate designs for the 2019 American Liberty High Relief 24K Gold Coin and Silver Medal.

Acknowledging the tight deadline for this third series of coins and medals depicting a new, modern American Liberty, the Committee evaluated a portfolio of designs offered during selection process for the 2015 and 2017 series.

Consensus was easily reached on this outstanding portfolio, by the recommendation of a left-facing Liberty, with thirteen rays of light symbolizing the free and creative spirit of America's people, emanating along a headdress. This design, HR-O-10, was also the favorite of the Commission of Fine Arts, and received 19 of 30 votes from the CCAC.

The reverse recommendation by our Committee for this series was HR-R-10, a close-up view of an eagle's head. A discussion among the members noted that no other US coin or medal had depicted the eagle in this manner, and the study of this proud symbol of our nation was an intriguing pairing for the Liberty obverse. This design received 15 of 30 votes.

The Committee is pleased to be a part of selecting designs for this series.

A public meeting of the Citizens Coinage Advisory Committee (CCAC) was held on Thursday, September 28, 2018, to review and discuss the candidate designs for the 2018 first coin of the American Innovation \$1 Coin Program.

The American Innovation \$1 Coin Act, Public Law 115-197, was enacted mid-year, and the Committee was cognizant of the responsibility to quickly but thoughtfully recommend the sole obverse that would be used for the next 14 years in this coin program, involving innovations from each of the 50 states, the District of Columbia and the five US territories.

The law mandates that the reverse bear the signature of George Washington as depicted on the first US patent, issued on July 31, 1790. The mint mark and date, along with "E Pluribus Unum," are to be edge-lettered in this series.

After robust discussion, the Committee recommended a bold design of the Statue of Liberty (2018-AI-O-08) facing left and holding high her torch. The negative space surrounding Liberty will make a distinctive and easily identifiable obverse. This design received 18 of 30 possible votes, and was also the preference of the Commission of Fine Arts.

The reverse design (2018-AI-R-08), bearing George Washington's signature above "Signed First Patent", was clearly the Committee's favorite, garnering 29 of a possible 30 votes. This distinctive design, with the United States of America on a diagonal strip separating a series of gears from the words "American Innovators" and the U.S. Patent Office relief on the Hoover Building in Washington, D.C., is a testimony to American industry and innovation. A discussion of using a gear as a privy mark for future designs may offer the collector of this new series a compelling reason to acquire each new coin, no matter how diverse the innovations or inventions.

The Committee is pleased to be a part of recommending designs for this series.

A public meeting of the Citizens Coinage Advisory Committee (CCAC) was held on Thursday, September 28, 2018, to review and discuss the reverse designs for the 2020 America the Beautiful quarter honoring Weir Farm (Connecticut) National Park for the Arts.

Two closely-related designs (CT-14 and CT-14A), each featuring a portable easel holding a canvas with the artist's painting overlaying the actual landscape at Weir Farm, captured the attention of the Committee. The scene is of the Weir House and Weir's Studio. The canvas and easel are portrayed in greater detail than the rest of the design, underscoring the mission of the site, which is to create a legacy of artistic expression as a National Park for the Arts. The Committee felt that a picture within a picture offered a unique "view" of this important park.

Design CT-14 received 29 out of 30 votes, and design CT-14A, the choice of the stakeholder, received 28 out of 30 votes. A motion was made to honor the stakeholder's preference, and this motion passed unanimously.
