A public meeting of the Citizens Coinage Advisory Committee (Committee) was held on Friday, April 19, 2013, at United States Mint Headquarters in Washington, DC. The Committee reviewed proposed obverse and reverse designs for the Code Talkers Congressional Gold Medal for the Muscogee Creek Nation.

The Committee recommended Obverse-03. The design garnered 22 of the possible 27 scoring points assigned through the Committee's evaluation process. For the reverse of the medal, the Committee strongly recommended Reverse-02. The design garnered 24 of the possible 27 scoring points. Members commented that the modern design of Reverse-02 would produce a beautiful medal.

A public meeting of the Citizens Coinage Advisory Committee (Committee) was held on Friday, April 19, 2013, at United States Mint Headquarters in Washington, DC. The Committee reviewed proposed reverse designs for the 2013 First Spouse Gold Coin and Medal Program honoring Edith Wilson.

Reverse design EdW-R-05 garnered 26 of a possible 27 points and, therefore, is submitted with a strong recommendation by the Committee. The design provides an illustration of Edith Wilson's hand on President Wilson's hand, which grips a cane. The design symbolically conveys Mrs. Wilson's important and compassionate role in assisting President Wilson in the execution of his duties following his stroke. Committee members remarked that the design provides a good balance of design elements and negative space and will produce a very attractive coin.

Dear Secretary Lew:

A public meeting of the Citizens Coinage Advisory Committee (Committee) was held on Friday, April 19, 2013, at United States Mint Headquarters in Washington, DC. The Committee reviewed proposed designs for the 2014 Presidential \$1 Coins honoring Presidents Warren G. Harding, Calvin Coolidge, Herbert Hoover and Franklin D. Roosevelt.

For the \$1 coin honoring President Warren G. Harding, the Committee strongly recommended design WH-07. The design garnered 21 of 27 possible points through the Committee's scoring process. Committee members commented that the design provided a well executed image of President Harding.

Design CC-05 was recommended by the Committee for the \$1 coin honoring President Calvin Coolidge. The design received 19 of 27 possible points through the Committee's scoring process. Committee members commented that the design captured the character of President Coolidge.

For the \$1 coin honoring President Herbert Hoover, the Committee recommended design HH-05. The design received 17 of 27 possible points through the Committee's evaluation process. The Committee felt design HH-05 provided an accurate portrayal of the 31<sup>st</sup> President.

Finally, design FDR-01 was recommended by the Committee for the \$1 coin honoring President Franklin D. Roosevelt. The design garnered 17 of 27 possible points through the Committee's evaluation process. Seven of the nine members participating in the evaluation assigned points to this design indicating broad support. Committee members commented that the design successfully captures President Roosevelt's personality.
